CSEA is committed to fighting the proposed reductions in hours and layoffs in Onondaga County, but we need your help **NOW!**

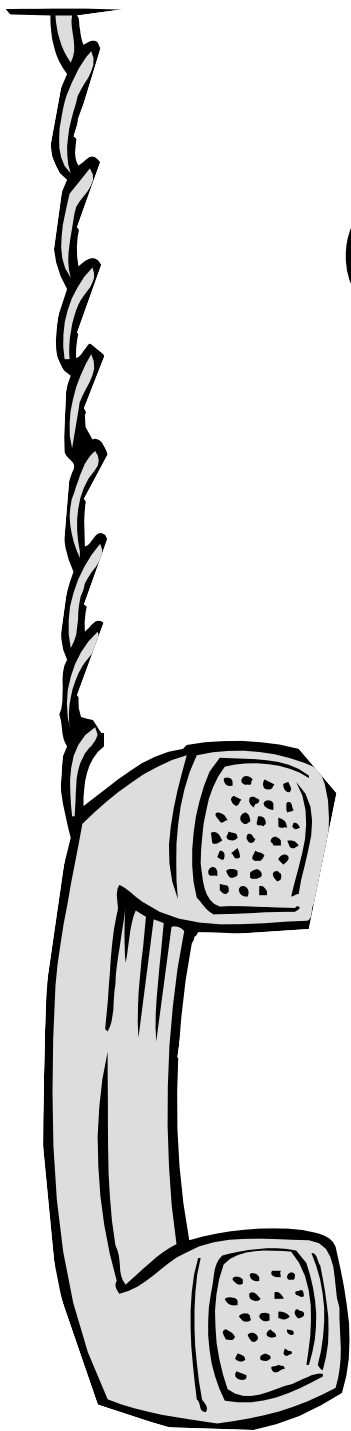
We need to send a strong message to our County Legislators that the Mahoney administration has ignored the **real savings proposals** that CSEA has made to save money, including:
